The Cerdanya Hospital, which is located on the border between France and Spain in the Catalan Pyrenees, is an unprecedented example in Europe of cooperation in healthcare (between the Autonomous Community of Catalonia and France). This hospital, which is a cross-border institution in terms of its governance (EGTC-CH) and its funding (France, Catalonia), brings together doctors and hospital staff of both nationalities who provide healthcare using the same protocols and the same technical facilities with no distinction to French and Spanish patients who are covered by their respective social security systems. When visiting it for the first time, one is pleasantly surprised by these teams in which medical staff work together, transcending their national background and speaking to one another in Catalan, Spanish or French while delivering highquality technical and specialised healthcare in a remote area far from the big city hospitals (Barcelona and Perpignan). The last hospital board meeting, which was chaired in turn by the Minister for Health of the Generalitat de Catalunya, Antoni Comin, and the Director-General of the Occitanie Regional Healthcare Agency Monique Cavalier, delivered a positive assessment of the hospital's activity, notably with an emergency department dealing with 25,000 cases a year and an imaging department using MRI and a scanner thanks to tele-imaging. The forthcoming hospital plan, which will be drawn up in 2017, will set out a roadmap for consolidation, with the development of telemedicine and the strengthening of links with community medicine and referral hospitals. With their enthusiasm and conviction that they are taking part in a European project that is helping to open up medical knowledge, the staff of the Cerdanya Hospital are giving us an example of successful cooperation.

## The cross-border Cerdanya Hospital: an example of successful cooperation

To be able to treat someone rapidly after a stroke requires coordination between local emergency services and specialist neurology and neurosurgery departments. In the remote area of Cerdanya on the French-Spanish border, which has a low population but is a popular tourist destination (six months of the year), the French and Catalan health authorities have put in place systems designed to reduce the risks for patients (who must receive medical attention within six hours of having the stroke). The crossborder Cerdanya Hospital is thus able to mobilise an emergency service (mobile and on-site) and modern technical facilities thanks to MRI, which, with the help of a

neurologist providing expertise remotely (in Barcelona or Perpignan), will enable a medical decision to be taken in the same way as for patients receiving treatment in a big city hospital. In order to put these systems in place, it has been necessary to work on medical protocols, IT links with referral centres, and staff training (harmonising the skills of x-ray operators and emergency doctors). A set-up with a fixed video camera in an emergency booth is linked to Barcelona and a set-up on a moving trolley is linked to Perpignan, making it possible to carry out other telemedicine procedures. ### Signature of the "Greater Geneva Territorial Project 2016-2030"

Nearly 200 people gathered on 8 December 2016 in Geneva for the signature of the "Greater Geneva Territorial Project 2016-2030", a third generation conurbation project: "We want to move from a financial rationale to a common political vision. We want to make Greater Geneva a collective, shared project that is led by the territory's citizens and stakeholders. We want to work towards the concrete and effective realisation of projects."

All of the French, Genevan and Vaudois partners have committed themselves to a common political vision and a series of projects designed over the coming years to shape the face of the cross-border territory, in areas as crucial as transport, territorial development and the environment. Several



- To reinforce the territorial structure of the French-Vaud-Geneva conurbation, anchored in the landscape and based on an urban framework closely coordinated with the overall transport network;
- To take ownership of the dynamics of Greater Geneva by aiming for the best territorial balance possible within its perimeter;
- To implement joint crossborder actions that benefit all of the populations in the crossborder area.

In terms of transport, the territorial project enables Greater Geneva to make an application to the Swiss Confederation in respect of the third generation of conurbation projects (Projets d'agglomération – PA3). For the four-year period 2019-2022

(tranche A of the PA3), the French-Vaudois-Genevan partners have therefore decided to present a reduced list of measures that are the subject of a request for cofunding. The third generation conurbation project contains 167 measures, of which 42 are eligible for co-funding from the Swiss Confederation in respect of tranche A. They represent a total investment cost of CHF 623.43 million (for "A" measures), of which 56% is allocated to public transport (trams and buses).

To support the area's infrastructure, the territorial project is accompanied by a four-year work programme in the fields of transport, the environment, territorial development and social cohesion.

The 5th Franco-Luxembourg intergovernmental commission (IGC) for the strengthening of cross-border cooperation was held on 21 November 2016 in Luxembourg, in the presence of Harlem Désir, Secretary of State for European Affairs (FR), and Corinne Cahen, Minister for the Greater Region (LU). Against the backdrop of a constant increase in the number of French residents working in Luxembourg, the topic of mobility and transport was at the heart of the discussions. # The EU proposes a revision of the rules on the provision of unemployment benefits between Member States

On 13 December in Strasbourg, the European Commission presented a revision of the European rules on the provision of unemployment benefits for cross-border workers and also for job-seekers in another Member State, in order to facilitate labour mobility. The proposal aims to establish "a closer link between the place where contributions are paid and that where benefits are claimed, in order to ensure a fair distribution of the burden between Member States".

## Study on the Greater Region's territorial development plan

At the request of Luxembourg's Ministry for Sustainable Development and Infrastructures, acting on behalf of the different bodies of the Greater Region's Summit, a consortium led by the North Lorraine urban planning agency (AGAPE) in collaboration with the MOT, the urban planning agencies of Metz (AGURAM) and Nancy (ADUAN), and the Technical University of Kaiserslautern, carried out an assignment to assist with the drawing-up of the Greater Region's territorial development plan. This assignment took place from September 2015 to November 2016.

The first phase of the study consisted in the analysis of planning documents by country (Belgium, Luxembourg, France and Germany) and of cross-border quidance documents. It was followed by a cross-cutting study of the three existing documents of the Greater Region's territorial development plan: the metropolitan dimension, transport and the economic component. A third phase consisted of a series of interviews with players in the territory in order to adapt the analyses and the contents of the plan formulated.

Several observations emerged:

- Economic development is regarded as being an issue "apart" in terms of cooperation for players in the Greater Region
- There is divergence in the way territorial development is understood by the different members of the Greater Region
- Two areas appear to be priorities: transport and improving living conditions for the population.
  The study was presented at the meeting of the ministers and political leaders responsible for territorial development in the

Greater Region on 23 November 2016 in Namur. The representatives approved the consortium's recommendation to adopt a process in four phases to draw up the plan:

- understanding: establishing a basis of shared knowledge
- strategic vision: adopting a common project for the future
- operational programme:
   determining priority actions
- monitoring: evaluating the process.

## ESPON seminar: "Where are European cities heading? Evidence for better policy-making"

A seminar organised by the ESPON programme and the Slovak presidency of the EU Council was held in Bratislava on 7-8 December 2016. Its objective was to promote the use of ESPON's findings and tools in decision-making processes, and to discuss future issues for European territories. The event focused on urban development; it was also an opportunity to present the ESPON tools and to create new partnerships for the targeted analysis activities.

A workshop was led by Jean Peyrony, the MOT's Director-General, on the topic of the challenges and solutions to be found with respect to crossborder cooperation. With presentations of concrete examples (Hungary's borders and the Strasbourg-Kehl tramline), it was an opportunity to set out the work of the Intergovernmental Working Group on Innovative Solutions to Cross-Border Obstacles launched during Luxembourg's presidency by Luxembourg and France, for which the MOT provides the technical secretariat.
