Committee of the Regions conference on

natural disasters in cross-border areas

Jointly organised by the Committee of the Regions and the MOT, this conference brought together more than 60 participants, on 3 February in Brussels. Its objective was to present best practice in the area of risk prevention and crisis management in cross-border zones: forest fires (ES-PT), flooding in the Nisa Euroregion (DE-CZ-PL), seismic risks in the Alps (FR-IT-CH), risks in mountainous regions (FR-ES) and more generally, civil protection (EGTC Euregio Senza Confini IT-AT). These concrete examples have helped to identify obstacles to cooperation, such as the lack of familiarity with the institutional system and relevant players of the neighbouring country, the

contradiction between the different States' administrative procedures, the lack of equipment or of linguistic capacities to communicate.

Among other solutions, the European Commission presented the financial tools available, as well as its overall approach concerning obstacles to cooperation (the "Cross-Border Review"). The MOT sought to underline the necessity of strengthening multi-level dialogue on each border. The debate was placed within a European and global context with an Opinion of the Committee of the Regions and the new UN Strategy for Disaster Risk Reduction under preparation. More info



The ALARM Project: "For security without borders"

"A shared region and shared risks must not be faced with obstacles to the carrying out of missions by emergency services in emergency situations." Identifying existing risks, learning to collaborate on a daily basis in order to react more efficiently in emergency situations, and promoting a citizen-culture of civil security: such is the ambition of the ALARM project, which brings together 26 French and Belgian partners. This "France-Wallonia-Flanders" tripartite initiative aims to develop an operational cross-

border cooperation between the civil security players on either side of the France-Belgium border at the different levels (risk analysis, planning, crisis management) and on a wide spectrum of cross-border risks. The project is structured around three axes:

- Integrated risk management, with the establishment of a networking platform
- "Day to day" operational cooperation, with the development of a cross-border plan for assessment and management of risks (STACR*)

and actions towards better communication between the emergency services.

- Involvement of local government and the populations.

The project held its launch conference on 31 January 2017, and is scheduled to continue working until 2020. It is co-financed by the Interreg VA France-Belgium programme.

Cooperation in the field of renewable energy and climate change adaptation



In September 2016, with the Heinrich Böll Foundation and the World Future Council, the MOT took part in a study tour from Copenhagen to Brussels, via Germany and the Netherlands. The goal: to study cross-border, transnational and interregional projects contributing to Europe's energy transition.

Certain cross-border projects demonstrate high added value:

- The FURGY Clean
 Innovation cross-border
 cluster helps businesses in
 the clean energy sector on
 the Germany-Denmark
 border in developing
 innovation, by promoting
 exchanges of experience,
 technology transfer,
 development of
 partnerships.
- The SEREH project is working towards setting up a cross-border smart grid

between the German town of Haren (which produces four times its own energy consumption thanks to renewables) and the Dutch industrial centre of Emmen, in order to create a local energy loop.

"Cross-border cooperation and climate change adaptation", in France

The French Ministry for the Environment, Energy, and the

Sea has launched a consultation of players for the elaboration of the new "National Climate Change Adaptation Plan". Following the evaluation of the General Commissariat for Sustainable Development, thematic working groups are together developing recommendations for spring 2017.

The MOT participates in the group "Action Internationale", for which cross-border cooperation is an important focus. It has brought its contribution in the form of a memo on the challenges of climate change adaptation in a cross-border context, and has made recommendations.

Impact in border territories of the law on public security

The vice-president of the MOT, Joël Giraud, member of parliament for Hautes-Alpes, is demanding special arrangements in border areas for authorisations for minors leaving the country. "What does a student at the agricultural college of La Motte-Servolex (Savoie) who makes the journey from Briançon to Chambéry have in common with the child of a family in Ile-de-France who takes a combined train/coach ticket for Paris to Montgenèvre? They both cross the France-Italy border twice even though their departure and arrival points are in

France. And, since 15 January, they can only make their journey when in possession of an up-to-date and correct authorisation to leave French territory. The problem for the first, is if the parents are in conflict and do not both sign the permit, the child has to give up studying. [...]." It is in seeking to avoid such absurd situations that Joël Giraud has been taking part in the general discussion of this draft law, as well as proposing amendments in order to find a legislative solution for border areas. France and Germany will test autonomous vehicles in a cross-border area

France and Germany have announced for the end of March the setting up of a test zone between the two countries for experimenting on the road with connected and autonomous vehicles. Along a 70km stretch linking the cities of Metz, in eastern France, and Merzig, in the west of Germany, the two countries particularly want to test communication between the vehicles via 5G, the overtaking of vehicles, as well as automatic braking, and cross-border automatic ("eCall") calls to emergency services. 5th Master-Class in Marseille

The 5th "Trans/frontières et dialogue des disciplines"* Masterclass was held in Marseille from 18 to 20 January 2017, on the topic "Young professionals and neighbourhood/proximity relations within the European Union? Between Conflict and Cooperation". This edition pursued the building of an academic network for the professionalization of students of high-level qualifications on European territorial cooperation and decentralised cooperation. The MOT, which moderated a roundtable, is an associated partner of this event. More info

In 2017 the MOT is celebrating its 20th anniversary!



On the occasion of its 20th anniversary, the MOT will be holding a large European conference, in partnership with the Committee of the Regions, in Brussels from 30 November to 1 December. The goal will be to take stock of the last 20 years of cooperation, to show the ground covered and the progress made in the service of cross-border territories, but also to debate persisting obstacles and the solutions to implement, particularly in the context of an ambitious European policy post-2020. A working group has been established for exchanges within the MOT network on all these questions, to decide on a format for the event, and to develop a MOT position paper.

Analysis of the "Letchimy" law (France)

Freeing up external action of French local and regional authorities

The "law relating to external action of territorial authorities and to the cooperation of overseas territories in their regional environment*" was adopted on 5 December 2016. This law, commonly known as the "Letchimy" law after the member of parliament Serge Letchimy who proposed it, modified article L1115-5 of the General Code for Local Authorities (CGCT), thus lifting restrictions on the external action of local and regional authorities. Indeed, the new dispositions allow, under certain conditions, for French local and regional authorities to sign conventions with States. This possibility, previously confined to the legal framework of existing European instruments, listed limitingly in the first subparagraph of article L1115-5, has now been extended "for the needs of a territorial or regional cooperation". The field of external action of

authorities has been opened up to include all anterior international accords approved by France, to the execution of all regional cooperation programmes also approved by France, and also to any other future cross-border, regional or inter-territorial cooperation grouping. This evolution, which has been progressive, attempts to allow French local and regional authorities to further develop their exchanges with the countries in their regional environment. Indeed, while the current decentralised regional cooperation has been meeting some success, obstacles, both de jure and de facto, persist and limit its full effectiveness. Thus, the Letchimy law gives local and regional authorities a clear legal framework for their cooperation efforts, which only serves to legitimise their outreach within their respective regional environments.



And although the law aims essentially to overcome the obstacles to the external cooperation of overseas territorial authorities mentioned in article 73 of the French Constitution of 1958, it brings about a major evolution for all French territorial authorities, particularly those situated on borders, as they now have the capacity to pursue a "diplomacy of proximity".
