

## The citizens of Europe express themselves in Tournai

Citizens turned out for the citizens' consultation held on 27 October by the Lille-Kortrijk-Tournai Eurometropolis, the MOT and the Jacques Delors Institute. This was a thoroughly European story: "Everything starts in the dark. There are around 120 people in the room, murmuring and wondering what awaits them. For the form of this evening is full of surprises and above all invites them to express their emotions, both positive and negative. All of a sudden a voice is heard: a storyteller appears on stage to tell the story of Europe. The aim: to give everyone a shared foundation to then facilitate dialogue." This was followed by discussions, stimulated by facilitators using innovative methods that gave priority to

expression by the citizens of the emotions associated with Europe: disgust with powerful lobbies, fear of the rise of populism, and love for the wider European family with which they live on a daily basis in the cross-border territory. These citizens also came together for a festive event to celebrate Franco-Belgian friendship and what unites them beyond any differences in opinion. Interviews were carried out, which show that citizens are ready to participate when they are asked for their opinion. ## On the way to Alsace as a European territorial authority

The French government has announced its support for the creation of a European territorial authority of Alsace, formed by the merger of the Bas-Rhin and Haut-Rhin Departments. It will be set up as of 1 January 2021. "We will support the elected representatives in their desire for Alsace. This will all be within the Grand Est Region – not a special status, but an authority with particular competences that derive notably from the cross-border setting and Alsace's Rhineland identity," stated the Minister for Territorial

Cohesion, Jacqueline Gourault. The new authority will be "the lead partner in cross-border cooperation". Its development will fall within the framework of the constitutional revision desired by the French President, with the wish to "start from a territory's competences" and to put in place "a foundation that can be built on in the future by lawmakers". The joint declaration signed by the parties concerned specifies that the European territorial authority of Alsace will be "charged with drawing up Alsace's overall plan

for cross-border cooperation", and that it will be able, like the other territorial authorities in the Grand Est Region, to draw on the Élysée Treaty,\* which will be signed in January 2019, as well as on the European mechanism aimed at removing legal and administrative obstacles currently being negotiated. Finally, it can serve as "an experiment with regard to the first measures taken within this framework".

# Europe supports universities without borders

In a new call for proposals, the European Commission is allocating €30 million to the European universities project: a major step towards higher education without borders.



The objective is clear: cooperation between universities should know no borders. The "European universities" initiative, supported by the European Commission, is in line with this aim. Through a call for proposals under the Erasmus+ programme, it is allocating a budget of €30 million to this new type of cooperation.

Thus, six alliances of European universities, each bringing together at least three higher education institutions from three different countries, will be supported by a pilot programme from 2019. Candidates must submit their applications by 28 February for this first phase. There is expected to be a second pilot phase the following year, with the aim of creating around 20 European universities by 2024.

The European universities initiative was approved by EU leaders at the social summit in Gothenburg in November 2017, and represents a step towards the creation of a European education area by 2025.

## Eucor - a European cross-border campus

The universities in the Upper Rhine (Basel, Fribourg-en-Brisgau, Haute-Alsace, Karlsruhe and Strasbourg) are with "Eucor" constructing an academic space without walls or borders. With over 115,000 students, this campus offers 10 or so joint courses leading to double or triple degrees. All of the students are able to take the courses of their choice across the five institutions without having to duplicate administrative procedures or pay additional fees. Moreover, the 15,000 lecturers-

researchers on the campus collaborate on very varied cross-border projects.

This campus may serve as an example for other borders.

## Report on the cross-border activities of French universities

Universities in France are involved in many programmes and activities that extend beyond the country's borders. The General Inspectorate of the Administration, National Education and Research (IGAENR) has drafted a report – as yet unpublished – that describes these activities, as well as the aims of, obstacles to and levers for cross-border university cooperation.

# NETWORK NEWS

## Study trip by a delegation from Haiti and the Dominican Republic

On 22-26 October, the MOT coordinated and accompanied the study visit of a delegation made up of representatives of ministries and local authorities from Haiti and the Dominican Republic. This project follows on from two assignments by the MOT in 2016 and 2017 in these Caribbean countries aimed at fostering the emergence of cross-border cooperation there. The objective was thus to build on this momentum by enabling the members of this binational delegation to get to know one another better through studying how cross-border cooperation is organised at the national level in France, as well as emblematic cross-border projects along the



Franco-Spanish border. The participants were first received by the MOT and then by the Ministry for Europe and Foreign Affairs and the French Development Agency. During the course of a field visit along the Franco-Spanish border, they learned about the cross-border actions of the Pyrénées-Orientales Departmental Council in Perpignan, the working of Cerdanya Hospital and that of the cross-border abattoir in Ur, before being received by the Cerdanya District Council in Puigcerdà. On the Basque border, the delegation was received by the Mayor of Hendaye; and it learned about the whole range of projects implemented by the Nouvelle

Aquitaine-Euskadi-Navarra EGTC, the Gipuzkoa Provincial Council in San Sebastian and the Basque Country Conurbation Community. The trip ended with a visit to the cross-border water treatment plant in Fontarabia in Spain, and by a presentation of the activities of the Bidassoa-Txingudi Cross-Border Consortium. The links forged during this week both between the two delegations and with the French and Spanish players will facilitate the development of decentralised cooperation along both Caribbean and European borders.

## France – the Minister Jacqueline Gourault sets out her vision for "the territories"

At the Council of Ministers on 7 November 2018, the Minister for Territorial Cohesion presented a communication on France's territories that sets out the Government's objectives with respect to them. This document points out that in order to "identify each territory's potential" it will be necessary to "build a 'bespoke' relationship with the players in that territory". It is to this end that the

Government will call on the National Agency for Territorial Cohesion that is being set up and that will incorporate part of the General Commission for Territorial Equality. The aim will be to "reinvent the method of dialogue" with territorial authorities and to put in place "a single point of entry" in the relationship between them and central government. Other initiatives that are mentioned are "the concrete experiment with

'territorial differentiation' with the example of Alsace", and the launch in 2019 of phase IV of the competitiveness clusters in order to build clusters with a European dimension.

"The exchanges between the two parliaments, which have hitherto been limited and ad hoc, will take on another dimension with the creation of a Franco-German parliamentary assembly. Made up of 50 MPs from each chamber, it will be set up in early 2019."

"On both sides of the Pyrenees, people seem to be convinced that it's best to act together with regard to climate. On Tuesday, the members of the CTP (Working Community of the Pyrenees) officially approved an innovative cross-border cooperation and development tool bearing the name 'Pyrenees Strategy'."
