

## The integrated territorial plan ALPIMED

Under the Interreg programme ALCOTRA on the Franco-Italian border, two types of plan can be implemented: integrated territorial plans and integrated thematic plans. Integrated territorial plans are made up of a series of projects organised around several themes for a specific cross-border territory. The ALPIMED integrated territorial plan is a plan for the rural and mountainous area of the "Mediterranean Alps", with funding of €7,155,000. It is organised around four single-theme projects focused on innovation, tourism, climate change and mobility: "ALPIMED INNOV" promotes access to innovation and the spread of new technologies among businesses and young people; "ALPIMED PATRIM" develops and markets a new cross-border tourist circuit; "ALPIMED CLIMA" raises the local populations' awareness

of climate change and is putting an action plan in place; and "ALPIMED MOBIL" encourages "soft" mobility. Supported by experienced partners, it is the Nice-Côte d'Azur Metropolis that is coordinating this plan, which involves representatives from the territories (the Alpes Maritimes Department, the Province of Cuneo, the Region of Liguria and the French Riviera Conurbation Community), chambers of commerce and industry (Nice-Côte d'Azur, Cuneo, the Ligurian Riviera) and protected areas (the Alpi Marittime / Mercantour European Grouping of Territorial Cooperation and the Gesso and Stura River Park). The projects will be implemented over periods of 36-48 months, from the end of 2018 to the end of 2022.

## The PAMINA Eurodistrict celebrates its 30<sup>th</sup> birthday

It was in the Alsatian town of Wissembourg that, on 12 December 2018, the 30th anniversary of the declaration of intent that established the PAMINA Eurodistrict was celebrated. Tribute was paid to the three founding fathers of PAMINA, Daniel Hoeffel, Dietrich Schmidt and Hans Kistenmacher, who received the PAMINA gold medal for their visionary work. Made up of the territories of Southern Palatinate, the Mittlerer Oberrhein

and Northern Alsace, since 1988 the Eurodistrict has been at the heart of Franco-German cross-border cooperation. "The border should not constitute an obstacle, but rather a factor for growth and development," emphasised the Eurodistrict's President, Rémi Bertrand. In this respect, the PAMINA Eurodistrict serves as a model: with more than 320 cross-border projects completed and €45 million in European funding received, it is an

example of cooperation and success. Having become the principal interlocutor on cross-border questions, the PAMINA Eurodistrict is now one of the players involved in the renewal of Franco-German cooperation and is actively participating in work on the Aachen Treaty, which will be signed on 22 January. ## Cross-border issues at the heart of the Grand Est Region's SRADDET

After two years of co-construction, the elected representatives of the Grand Est Region presented the major elements of the Region's SRADDET<sup>1</sup> at an event in Metz on 30 November 2018.

Two roundtables were held on the plan's two strategic priorities: the ecological and energy transition on the one hand and territorial and cross-border cohesion on the other. The MOT, which participated through the whole of the drafting process, was represented by its Director-General, Jean Peyrony.

The SRADDET, which was introduced by the NOTRe<sup>2</sup> Act, is a crucial tool in the construction of the new region, alongside the SRDEII<sup>3</sup>. Together they constitute the two driving forces of the Region. "The SRADDET encompasses sustainable development, biodiversity, transport, waste, and a whole series of areas that are the subject of specific plans that need to be encompassed in a single plan," explained Franck Leroy, the Vice-President in charge of territorial cohesion in the Grand Est Region, at the event.

The Grand Est Region's strategy for spatial planning and sustainable development up until 2050 sets out thirty objectives around two key pillars that place cross-border cooperation at the heart of the document:

- Pillar 1: Switching to a virtuous development model for its territories  
- Pillar 2: Transcending national borders and strengthening cohesion for a connected European area.

Launched in February 2017, the drawing-up of the SRADDET was the subject of a broad consultation process involving nearly 3,000 stakeholders (territorial authorities, central government, players from the energy, transport and environmental sectors, associations, etc.), 245 written contributions and opinions gathered from 2,900 citizens.

The presentation marked



the beginning of a new phase of consultation, with the launch in January of a large-scale public survey. The plan must be adopted by 27 July 2019. [More info](#)

### Contributions from urban planning agencies

The seven urban planning agencies in the territory provided their expertise, notably with the publication of an 88-page document entitled "Cross-border issues and challenges".


## Ninth meeting of the working group on innovative solutions to cross-border obstacles

On 18 December 2018 the ninth meeting of the working group on innovative solutions to cross-border obstacles was held in Brussels at the European Committee of the Regions. It was an opportunity to take stock of the different initiatives underway aimed at overcoming cross-border obstacles. The process of adopting the proposal for a regulation on the ECBM (see below), the projects being implemented within the framework of DG REGIO's "B-Solution" call for projects, as well as testimonies regarding the potential uses of the ECBM tool enabled the central government and local players, as well as the representatives of the European institutions present, to contribute to the debate.

## A new edition of the MOT's Guides, on the energy transition

On the occasion of the European Conference on the Energy Transition, which is taking place in Dunkirk on 22-24 January 2019, the MOT is publishing a new edition of its thematic Guides, on the energy transition and cross-border cooperation.



The 24-page publication presents in the first part **the cross-border territories as "fully-fledged players in the energy transition"**.

Nine good practices illustrate the diversity and "value added" of cross-border projects in four sections:

- 1. Sharing experiences to develop appropriate solutions**, with the examples of the "TRION-Climate" network, the PASSAGE project on European straits and the SEREH project, which has enabled the development of an energy community on the German-Dutch border.
- 2. Encouraging economic**

**development**, with the "specialisation strategy" of the Nouvelle Aquitaine-Euskadi-Navarra Euroregion, and the "Zero Emission Valley" scheme in the Auvergne-Rhône-Alpes Region.

**3. Planning the energy transition**, with the experiences of Greater Geneva and the "mobility eco-bonus: towards a smart cross-border city".

**4. Experimenting along borders**, with the Smart Border Initiative: the "Smart Grids" solution.

**A dossier entitled "Cooperating in the area of the energy transition"** then

sets out **the obstacles, and the solutions and tools proposed at the local, national and European levels.**

The brochure was written in French and English, in partnership with the MOT's network and with participation from the Banque des Territoires – which wrote the editorial, as well as from ENEDIS, the Ministry for Ecological and Inclusive Transition, the National Observatory on the Effects of Climate Change, and from European networks that work on the energy transition such as the Heinrich Böll Foundation and Energy Cities.

## Opinion of the Parliament and the CoR on the proposal for a regulation on the ECBM

In adopting its opinion on the proposal for a regulation on the ECBM on 22 November 2018, the European Parliament's Regional Development Commission (REGI) embarked on the process of inter-institutional negotiations on the proposed tool. This opinion principally emphasises the voluntary nature of the future mechanism, which Member States should be able to choose to apply or not, notably leaving, for justified reasons, a legal or administrative obstacle unresolved, and also within longer deadlines than those initially envisaged. Similarly, REGI believes that the ECBM should apply to all of the EU's border regions, on a case-by-case basis (depending on the projects concerned), and with the obligation on all Member States to set up national coordination points. The Ministry of Europe and Foreign Affairs has launched a call for projects aimed at funding decentralised cooperation projects supported by French local authorities in partnership with foreign local authorities. This call is also aimed at implementing in the territories Agenda 2030 for sustainable development and the Paris Climate Agreement. One of the seven priority themes selected relates to cross-border cooperation. The deadline for the submission of projects is 15 March 2019.

It does not claim to be a panacea for all of the area's ills, but it is a tool that can be used to tackle coherently all of the issues relating to cross-border workers."
